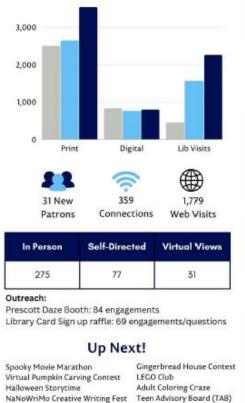
A motion to approve the September 15, 2022, Library Board minutes was made by Susan Oney, seconded by Tasslyn Magnusson, and carried.
